We were on a good path when the soft closure began. We will need to back up a bit and get back on solid ground when school resumes in the fall so we can continue our progress.

We were building capacity with teachers in our school as they took coaching training. We will continue to work with coaches and to build capacity with our teachers, but it may look a little different than it did this year.

- 3 Focused, targeted interventions will be provided to above students regularly.
- 4 Students will be monitored regularly (Acadience or similar). Interventions and instruction will be adjusted accordingly.
- 5 Some PLC time will be devoted to these particular students' progress.
