C. Review of 2024-2025 RISE scores and 2025-2026 Land Trust school goals

1. ELA Goals (based on Acadience)–score went down by 5.5%
 - a) Wit and Wisdom was implemented last year
 - b) 2 coaches
 - c) “floater aide” (lots of positions–specifically 2nd grade math) and 1st grade aide
 - d) Tamara going over the specific goals for Riverside
 - (1)USBE goal: 70% of third graders should be reading on grade level by the end of the 2026-2027 school year.
