6. 1 District Annual Facility Assessment list for the cones in the parking lot
 - a) *how has the parking lot been since we implemented the cones?
 - (1)the through lane is still moving well
 - (2)pick-up is cleared out within 10 minutes
 - (3)safety has improved, kids are using the crosswalk and not running across the driving lanes
 - (4)maybe keep someone just a few minutes after the bell rings to prevent parents from curb-parking to bring students in that are "tardy"
 - (5)handicap stalls are being "camped" starting at 2:45 that can prevent people who need to use those stalls during school hours

1. Previously was funded through Literacy and Community Outreach for parents/children wanting to learn English

 - a) let them know that we have the space (might need to be creative in classroom space)

C. Title 1 comparison of funds (40.03% economically disadvantaged)

1. Now called EARS funding
 - a) 2021-22: \$336,000
 - b) 22-23: 60% reduction in funds (cut across the board)
 - c) 23-24: 95% of 21-22 allocation
 - d) 24-25: 104% of 21-22 allocation

 - a) students rushing to the front of the line so they have more time to eat
 - b) 5th grade students getting out of control
 - c) bottle flipping milk container rather than eating
 - d) only get three breaks a day, feels like a long time between breaks

 - a) went to the school board to discuss lunch times
 - b) enough time to talk with friends and eat food
7. Meghan Shelby
 - a) students develop more empathy when they have the time to chat at lunch
 - b) came in and timed the lunches with Dr. Trimmell
 - (1) on average had 7 minutes to eat their lunch
 - c) 75% of the students in the general education classrooms are on free/reduced lunch and are the ones that might benefit the most from extended time
8. Jerilyn Schafer
 - a) sent a survey out to principals—25 responses
 - (1) 48% of schools have 15 minutes
 - (2) 8% have 20 minutes
 - (3) 12% have 10 minutes
 - (4) Other much smaller percentages gave a variety of feedback
 - b) many said they eat and then go, some are held for a certain amount of time
 - c) guiding coalition of teachers will be giving input for the schedule next year
 - d) strict guidelines that include cleaning the tables, so need to have time for that
 - e) will check into recycling food
9. Natalie
 - a) timed—had 9 minutes to eat
 - b) amount of food was a lot
 - c) helped open milk, peel orange, retrieved silverware
 - d) at a previous school, leftover food was saved for later students
 - e) overheard workers saying “you have 5 minutes left...time’s up...throw your trays away and go outside”

 - (1) Tamara—I don't have students. I can see both sides of it
 - (a) fine line between too much and not enough
 - (b) have to make the best decision for 600 kids
 - (2) Laura Barton (first grade teacher)
 - (a) start taking students down 5 minutes early (cleared by administration)
 - (b) eat slower and talk more
 - (c) have to make our instructional minutes count (meet district requirements)
 - (d) trying our best to balance everything

- a) Meghan Shelby emailed Lisa Dean (on the school board)
 - (1)when a teacher is paid on teacher's salary, they can get a sub, but when not paid through those funds, then there is no compensation/funding for substitutes
- b) art teacher is paid partially through BTS (Beverly Taylor Sorensen)-- and partially through our funding
 - (1)next year we will be responsible for more of this funding
- c) STEM, librarian, PE are "aides" and paid accordingly
 - (1)could there be a "floating" aide that could cover any absent aide and help with other interventions, etc. when not being used in rotations
 - (2)part-time teacher to cover it?
 - (a)brought up in SAC (School advisory committee) as well to get teacher input
 - (b)funding allocation still determines whether they would be able to get a sub
 - (c)funding this would cut funding in a different area
- d) Teachers are frustrated when rotations are cancelled
